  - 2. The developer/owner prepare and submit the Registration of Discharge form and operation plan to the Ministry of Environment for expansion of the service area, increasing the sewage flows and all infrastructure upgrades required to raise the level of sewage treatment to Class A standards.
  - 3. The developer is required to provide all upgrades to the existing sewage treatment system to achieve Class A effluent quality for a combined total of 92 lots, including all upgrades to the septic fields or other treatment works.
  - 4. The developer undertakes to provide a two-year warranty on the completed sewer and water systems, backed by suitable bonding.
  - 5. All infrastructure works, located on private property, are placed within registered Statutory Rights-of-way using the CVRD's standard charge terms.
  - 6. All sewage disposal and water supply capacities must be confirmed by the developer.

- 7. The developer is required to provide all water and sewer servicing infrastructure, including pumps, controls and mainlines for the proposed 31-lot subdivision; as well as all upgrades or construction as necessary to provide interconnects and pipeworks to accommodate the new servicing configuration.
- 8. The developer is required to provide a fire pump, replace the existing water treatment system with a CVRDapproved treatment system and provide a genset, complete with an automatic transfer switch; and pre-payment of the cost of water meters at approximately \$100 each.
- 4. That the CVRD consider applications for takeover of "ornamental" streetlighting on a "case by case" basis.
- 5. That the CVRD provide a letter of support for the Cowichan Community Land Trust Society Invasive Species Education and Outreach project, indicating that the CVRD considers the project to be critical for the Cowichan Valley and that the CVRD will provide in-kind support for the project, of approximately two hours per week of staff time, as well as maps and information sharing.
