Purpose:

To inform the Parks Committee of the Cobble Hill Mountain Recreation Area agreement pertaining to land recently designated as Interpretive Forest by the Ministry of Forests.

Financial Implications:

Background:

In July 2001 the Cowichan Valley Regional District entered into a 30 year agreement with the Province to maintain and manage the trails for hiking, equestrian and mountain bike use on provincial forest lands on and around Cobble Hill Mountain. The provisions of long-term agreement included the Regional District preparing a Recreation Area Management Plan to determine the long term direction for recreation usage and development of the site. This plan was subsequently completed, covering approximately 406 hectares (1,003 acres) of provincial forest lands around Cobble Hill Mountain, and adopted by the Regional District Board in the spring of 2003.

However, at the time of the plan's adoption, the Ministry of Forests clarified that the 30 year agreement only applied to Forest Recreation Reserve #0202, which covered 114 hectares (275 acres) of the overall area identified in the management plan and that the remaining provincial forest lands would require re-designation by the Ministry to Interpretive Forest in order for the Ministry to include these lands within the 30 year agreement (see attachment). The reason for the Interpretive Forest re-designation requirement was to ensure that the established woodlot licensees on these lands could continue to operate their woodlots within the lands while also permitting the recreation management on the lands by the CVRD. Due to a number of staff changes at the Ministry, the Province's process to officially designate the remaining 292 hectares (728 acres) Interpretive Forest has taken several years (see attachment). At this time the

has expanded authority under the 2001 agreement for the recreation management on the entire 406 hectares (1,003) acres as approved by the Regional Board in the adopted 2003 Cobble Hill Mountain Recreation Area Management Plan (see attached map).

As a first step towards implementing elements of the 2003 Recreation Area Management Plan in the expanded Interpretive Forest, CVRD Parks and Trails staff will be meeting in early fall with staff from the Ministry of Forests, the Ministry of Sport, Tourism and the Arts and the two woodlot licensees that operate within this Interpretive Forest to review the plan's intended recreation access and development for this area and how these objectives can be harmonized with the current plans of the woodlot licensees. This is a key component of the 2003 Recreation Area Management Plan, which recognizes the active role of the provincial woodlot program within a good portion of the overall recreation area, and the need to co-ordinate/manage public recreation on these lands with woodlot operations.

Background:

The Cowichan Valley Trail Initiative is a 120 km multi-use trail route linking communities throughout the Cowichan Valley Regional District, including planned extensions to the Galloping Goose Trail in the Capital Regional District and the Trans Canada Trail in the Regional District of Nanaimo. The Trail Route encompasses both "Rail to Trail" along former railway rights-of-way and "Rail with Trail" for sections of the trail within the Island Corridor Foundation's active E&N Corridor.

In October of 2008, the Island Coastal Economic Trust (ICET) formally announced funding of \$1,743,891 for the Cowichan Valley Trail initiative of which \$1 million is earmarked for the Kinsol Trestle Rehabilitation and the remaining \$743,891 is targeted towards completion of the Cowichan Valley Trail. The trail initiative looks to complete 8 trail components over a 4 year period (2009-2012), including links from:

- Ladysmith to the Regional District of Nanaimo,
- A "Rail with Trail" between Chemainus and Ladysmith,
- A new trail from Duncan to Chemainus/Crofton,
- Upgrades to the Rail to Trail section from Lake Cowichan to North Cowichan, and
- Rehabilitation of the historic Kinsol Trestle.

In addition to the ICET funding the CVRD Board previously approved \$400,000 in federal gas tax funding for the project and matching \$400,000 from the Regional Parks Budget to complete all eight segments. In summary, the funding for the overall project, which will take place between 2009 and 2012, is as follows: (as per Board approval of grant funds)

The work program for 2009 includes performing upgrades to three of the eight segments identified in the 5 year financial plan.

- A. Rail to Trail Section Lake Cowichan to Duncan
- **B.** Bings Creek Bridge

C. Rail with Trail Section – Chemainus Area

The following is an update on what has been completed in 2009 thus far on each of these project areas:

A. Rail to Trail Section - Lake Cowichan to Duncan - 26km

In the spring of 2009 a detailed assessment was performed by FJM Management on the section of trail between Greendale Road in Lake Cowichan and Sherman Road in Duncan. This assessment included documenting the condition of the trail surface and corridor, condition and location of all culverts, location of all access points (road and trail), and a comprehensive list of recommendations, quantities, and cost estimates for works such as ditching, grading, surfacing, culvert repair/replacement, access armoring, and other works related to the trail.

Following the completion of this assessment the 2009 work program began. Work completed to date includes the following:

- Brushing of the rail to trail corridor to 5 metre width to allow trail surfacing and grading
- Hazard tree removal
- Grading of the trail surface where required to address uneven surface conditions
- Blocking of all accesses using temporary gates (lock blocks with cable in reflective conduit strung across the trail access)

Telus, managers of the Teleglobe fiber optic line that runs underneath this entire section of the E&N Spur Line, have partnered with CVRD Parks to contribute to trail improvements taking place. This includes cost sharing of the corridor brushing, repair and replacement of all culverts in need of work, and bank stabilization at the Bings Creek Bridge site,

Significant work has also been performed at the Sherman Road and Greendale Road Trailheads:

Sherman Road

- Trail surfacing gravel has been placed and compacted from Sherman Road to Agira Road (225 m) _ to create a level trail surface for walkers, cyclists and equestrians.
- A gate has been installed and rock has been placed at Agira Road to prevent unauthorized vehicle access.
- A large kiosk/sign, split-rail fencing, and rock armoring has been installed at Sherman Road.

Greendale Road

- Trail surfacing gravel has been placed and compacted from Rockland Road to Pine Street (1000m) to create a level trail surface for walkers, cyclists and equestrians.
- A large kiosk/sign, split-rail fencing, and rock armoring has been placed at Greendale Road. Signs have been installed along Pine Street directing users south along the trail.

Work will continue into the fall and will include ditching and trail surfacing as required, signage installation at each road crossing, and the current temporary gates will be replaced with removable bollards and rock armoring. Additional work on this section of trail is planned with dedicated funding in 2010.

B. Bings Creek Bridge

A draft bridge design has been created by Herold Engineering for the crossing at Bings Creek. This design is currently under review and will be finalized in the coming weeks. Installation of the bridge in 000014 2009 is pending fisheries approval and the ability to construct and install the bridge prior to the fisheries work window deadline of September 15^{th} . If the bridge is not constructed in 2009 work will carry over to 2010.

Bank stabilization work is required on the south side of the creek over the fiber optic line. This work is being organized and funded completely by Telus.

Other work that will be performed in the area includes trail surfacing to Holiday Lane and construction of approach trails on the north and south sides of the crossing.

C. Rail with Trail Section – Chemainus Area – 1.3km

2009 work on the Rail with Trail in Chemainus will include construction of a 3 metre wide trail from River Road south to Chemainus Road at Crozier Road. The trail will be constructed to the "Vancouver Island Rail Corridor Rail with Trail Design Guidelines," which was finalized and approved in June 2009 by the Island Corridor Foundation. The Chemainus Rotary Club is an active partner in the project with additional funds raised by the club allowing more work to proceed than was planned for 2009. The District of North Cowichan has also been contributing to the design and layout of the trail.

The trail alignment follows the west side of the tracks from River Road to the MacMillan Bloedel Haul Road. At the Haul Road, the trail crosses the tracks and follows the east side to Henry Road. At Henry Road, users will cross using the designated cross walk, then cross the tracks to the west side. The trail will follow the west of the tracks south to Chemainus Road. This final stretch will border Mt. Brenton Golf Course, with whom the CVRD has been involved since the planning of this section of trail first began.

Pending Southern Rail's final approval of the trail layout next to the active E&N tracks, a Request for Proposals will be issued for the proposed works. Work will commence once the RFP is awarded. The target for the successful contractor to complete the work is October 2009.

Background:

The Parks and Trails Division continues to receive numerous requests from the public for park brochures of the regional park sites (i.e. Spectacle Lake, Sandy Pool) and the Cobble Hill Mountain Regional Recreation Area, in particular pertaining to activities available at these sites and information on trails. With the hiring a Parks Planning student for the summer of 2009, funded in part under the Regional Parks Program, a key task was to produce a brochure template that could be used for all Regional Park and Regional Recreation Area sites.

The layout and design for the brochure template involved investigating what other local government parks agencies have produced by way of park brochures and assessing key information that should be provided in a regional park site brochure, including history of the park, activities and opportunities, trail map information and appropriate park visitor expectations and conduct. The enclosed regional park brochure template incorporates space for this information that would be customized for each regional park site, as well as portraying a CVRD Regional Parks recognition theme to the brochures through the use of standardized layout, colours and use of the Cowichan Valley Regional District logo. Direction from the Parks Committee on the enclosed template at this time allow the remainder of the brochures to be

completed by the Parks Planning summer student prior to completion of the work term at the of August.

Re: Chase Woods Property Purchase

Dear Mr. Dorey,

I am writing today to alert the CVRD Regional Parks Committee of an opportunity to provide support the Nature Conservancy of Canada to acquire a 100-acre (40-hectare) property on Mt. Tzouhalem, which we call Chase Woods.

The Chase Woods property rises from the valley bottom to the 400 metre summit of Mt. Tzouhalem. The white cross, visible from many points in the Cowichan Valley is located on the Chase Woods property, making this a truly iconic place. A series of trails located on lands owned by the Municipality of North Cowichan connects with trails on Chase Woods that lead to the cross. While recreational use of the property will be subject to NCC's management planning, NCC anticipates keeping these popular hiking trails to the cross open and available to the public.

The conservation values of Chase Woods are considerable. The property contains representative examples of all of the moisture gradients associated with the Coastal Douglas fir ecosystem – from riparian areas to dry Garry oak bluffs rich with wildflowers, and including old growth Douglas fir stands. The property contains several rare species and seven different globally imperilled plant community types. First Nations cultural values on this property are also present.

The Nature Conservancy of Canada (NCC) has a conditional purchase and sale agreement with the current owner of the property: 98-year-old David Chase. NCC's total project budget to complete the purchase, and cover its associated costs and short- and long-term stewardship needs, is \$1.7 million. So far, pending two strong pledges materializing, NCC has raised over 90% of the project budget, and is striving to secure the last \$145,000. NCC must find this funding by July 24th in order to remove the purchaser's condition precedent for project funding.

The community of the Cowichan Valley has been extremely generous toward this funding campaign, so far contributing almost \$20,000 in amounts ranging from \$25 to \$5,000 at a time. Several local business owners have donated their time and business

profits to help with the effort. While this support has been wonderful, we do need to find the last lead gift to allow us to complete this purchase. If we do not receive pledges for the funding by July 24th, we will be forced to seek an extension of the purchase contract, something which the vendor and his family are reluctant to grant given the age of the vendor. To ensure that we can realize this limited opportunity, we need to secure the remainder of the project funding this July.

This letter is submitted to the CVRD Regional Parks Committee in hopes that the Parks Committee may be able to provide some funding support to the Chase Woods project to ensure that this ecological treasure is conserved in perpetuity as a vital piece of the Cowichan Valley's natural and cultural heritage.

"Right now we're busy undertaking the works this year and next year to link the town of Lake Cowichan with Duncan/North Cowichan using the existing railway grade that is actually owned by the Island Corridor Foundation," said Brian Farquhar, parks manager for the Cowichan Valley Regional District. "It's part of the old spur line that used to run up to the town (of Lake Cowichan) to the Honeymoon Bay area and Mesachie Lake."

The work is concentrating on 26-kilometres of trail at a cost of about \$340,000 in grant money from Island Coastal Economic Trust, regional parks funding, federal gas tax funding and from Cowichan Tribes.

"We started some initial clearing back in May and we're just now finalizing details in terms of the culverts and grading and everything else," said Farquhar.

Farquhar said the current work linking the trail from Sherman Road on the North Cowichan end to Greendale Road, just at the east end of the Town of Lake Cowichan is one of several elements the CVRD is working on during the next three years to complete the link from the town of Lake Cowichan up to Nanaimo regional district's Trans-Canada Trail, north of Ladysmith.

"With the improvements we're doing now you'll be able to go from the old CNR rail line, which is our Cowichan Valley Trail, onto the old E&N spur to come back to Duncan-North Cowichan on the north side of the river," Farquhar said.

"And from just north of Duncan where the rail line comes back it will use existing portions of the active E&N rail right of way, which is 100-feet wide with the tracks right down the middle."

The overall objective is to have everything — including the Kinsol Trestle (a vital link in the Trans-Canada Trail) and the connection with Victoria's Galloping Goose Trail — substantially completed by 2012.

TimberWest will require liability insurance for back-country access

NANAIMO — Growing restrictions to back-country access will include liability insurance, says major landowner TimberWest. The forest firm, which owns approximately 33,000 hectares of land around the Nanaimo Lakes, is increasingly restricting public access to the land this year. While the public has enjoyed easy access to the popular areas for many years, growing concerns about suspicious fires, vandalism and timber harvesting has caused TimberWest to start severely limiting access to areas popular with hikers, campers, hunters and others.

Access into the area is now blocked with a locked gate, and those who request permission to access the area must have appropriate liability insurance.

A number of outdoor clubs, including the Nanaimo Fish and Game Protective Association are growing increasingly concerned that they are losing access to the land.

TimberWest spokeswoman Sue Handel said TimberWest has always had a policy of controlling public access to its land, but they are being applied more stringently this year.

"Setting accessibility rules for our property is a moving target and we review them all the time," Handel said. "We understand there are some concerns being raised this year, but nothing has really changed in the way we manage our lands; it's just that it has come to light in the media. People can request permission to access the land and we'll deal with them on a case-bycase basis, but those we admit will have to have their own liability insurance."

Sharlene MacLellan, president of the fish and game club, said it us unfortunate that TimberWest is having to take more measures to restrict access to its Nanaimo Lakes land this year, but acknowledged the company's concerns around safety and liability.

"It would seem it takes a few to spoil it for everyone." she said.

Club member George Denton agreed.

"With everything going on in that property this year, you can hardly blame TimberWest for taking these measures and I'd gate it up as well," he said. But MacLellan and Denton said club members are concerned they won't have access to their traditional elk hunting grounds in the area when the season opens this fall.

"We're hoping Timber-West will be willing to make exceptions for our elk hunters," Denton said.

Handel said TimberWest intends to try to open up the area for hunters in the same manner it was open last year, but that decision will be made a later date.

Close to \$1 million dedicated to western half of a trail linking the Alberni and Cowichan valleys

he Island Coastal Economic Trust has opened its coffers to help develop the western half of Runners Trail, linking the Alberni and Cowichan valleys. Port Alberni councilors listened as economic development manager Pat Deakin outlined the initiative in a report to council. ICE-T awarded \$450,000 to project partners the City of Port Alberni, Tseshaht First Nation and Alberni-Clayoquot Regional District. The total cost of the project will be \$929,000. Half the cost is underwritten with the ICE-T funds, while the other half is made up of Job Opportunities money the city received last year. The work will start this summer and is slated to

be completed by 2011.

The project will be coordinated in a three-way effort. The city will provide a job safety supervisor. ACRD will contribute mapping services. And the Tseshaht will manage the project. The western half of the Runners Trail will run east from Headquarters Bay at the southern end of the Historic CNPR Alberni Inlet Trail to Francis Lake (approximately half-way to Cowichan Lake). ICE-T committed \$76,000 in 2008 to help start this project.

"The intent of the Runners Trail project is to help develop a major trail network in the Alberni Valley as one means of diversifying its economy," said Barry Janyk, chair of ICE-T. "The objective is to reopen the historic route of the Canadian Northern Pacific Railway grade between Port Alberni and Lake Cowichan via Alberni Inlet."

Tseshaht First Nation Chief Councillor Les Sam said that the "Runners Trail" name recollects the traditional routes used for news and travel from Ditidaht to Cowichan in one direction and Alberni in the other.
