



Cowichan Valley Regional District Recreation Centre COVID-19 Transition CLR User Memorandum

The CVRD has been taking a staged approach in restoring services. The timing of each stage and the restoration of individual programs and services are ever-evolving as the BC Restart Plan rolls out. A number of health and safety measures have been put in place since March 2020, and as we work through easing restrictions, we ask users to take into consideration the following:

- Mask use is recommended when visiting our indoor facilities.
- Self-screening prior to entering a facility or attending a program is required. If you are not feeling well, please stay home and do not attend.
- Contact tracing for visitors and spectators is no longer required.
- Physical distancing is no longer required; however, we do ask that you respect the comfort level of others and maintain space between people not living in your household; some facilities may still have directional arrows in place (especially in tighter corridors and we ask that you continue to adhere to these to allow comfort for all patrons).
- Although COVID-19 levels of cleaning are no longer required, the CVRD Recreation facilities will continue to keep an enhanced level of cleaning as we transition back to normal services.
- General access to the facility remains limited as staff work towards increased operational capacity and transition back to full services. Please follow signage displaying entrance and exit information.
- Organized gatherings remain limited based on the current [Provincial Health Order](#); if you are a renter of the facility, please ensure you review these guidelines and follow all required restrictions. Additional facility specific guidelines may also be in effect due to operational restrictions of each facility.
- Dressing rooms, shower use, and washrooms will transition back to pre-COVID-19 usage.
- Cowichan Lake Recreation will continue to have chairs, physically spaced, for those who prefer to use these instead of a more crowded dressing room.
- Patrons are encouraged to continue handwashing upon entry and exit of facility or utilize the hand sanitizer provided at entry points.
- Food and Beverage services will be reinstated in Fall 2021.
- User groups/contract holders are responsible for adhering to capacity limits for their rental, including spectators.
