#### CVRD lifts State of Local Emergency, Evacuation Alert for area residences

**DUNCAN, BC –** The CVRD's Regional Emergency Operations Centre (REOC) is lifting the State of Local Emergency for the Mt. Hayes wildfire and rescinding the joint Evacuation Alert for 20 residential properties in the surrounding area.

The joint Evacuation Alert with the Regional District of Nanaimo that is being lifted as of Tuesday night is for addresses on Takala Road, David Road and Ivey Road, and based on the recommendation of BC Wildfire Service (BCWS).

The Mt. Hayes wildfire continues to be classified as "Being Held" and the containment line has successfully aided the efforts of BCWS crews. Ongoing suppression efforts are focused on the area to the south where the fire is dug in and continues to burn.

As a result, residents may experience wildfire smoke for the next several more days and are advised to take steps to limit exposure.

The Evacuation Alerts for the FortisBC facility and the Bush Creek Fish Hatchery continue to remain in place.

On Wednesday, the CVRD is downgrading the REOC to a Level 1 and will continue to receive updates from BCWS.

No further updates are expected unless there is a significant change to the status of the fire.

The CVRD wishes to extend its thanks and appreciation to the public and media for sharing information during the Mt. Hayes wildfire and other emergency incidents.

- · The area north of Tyee Creek in Electoral Area G

and is therefore cancelled effective this date at 2000hrs.


