



The Cowichan Valley Regional District (CVRD) is proposing to adopt "CVRD Bylaw No. 4413 – Park Land (Sutherland Park Trail), Disposal and Exchange Bylaw, 2022" which would allow the CVRD to dispose of park land vested in the Regional District by subdivision as shown in Figure 1 on the reverse of this form and legally described as PID 029-642-744, Lot 6, Section 4, Range 7, Cowichan District, Plan EPP50188; and exchange the land for other private land suitable for park purposes as shown in Figure 2 on the reverse of this form, legally described as "Lot B" on reference plan EPP114514, within the Electoral Area D Community Parks Service Area. There is no taxation impact to the electors of Electoral Area D – Cowichan Bay as a result of the disposal and exchange of the subject lands. If you are opposed to the adoption of this bylaw, you may indicate your opposition by signing and returning this Elector Response Form to the Regional District office by 4:30 PM, Thursday, May 12, 2022. Only those persons who live or own property within Electoral Area D – Cowichan Bay and meet the following qualifications are eligible to submit an Elector Response Form.

I hereby certify that:

- I am a Canadian citizen;
I am an individual who is age 18 or older;
I have been a resident of British Columbia for at least the past six months;
I am a resident of Electoral Area D – Cowichan Bay or I am entitled to register as a non-resident property elector;
I am not disqualified by the Local Government Act, or any other enactment, from voting in an election or am not otherwise disqualified by law.

I understand and acknowledge that I may not sign an Elector Response Form more than once in relation to this alternative approval process.

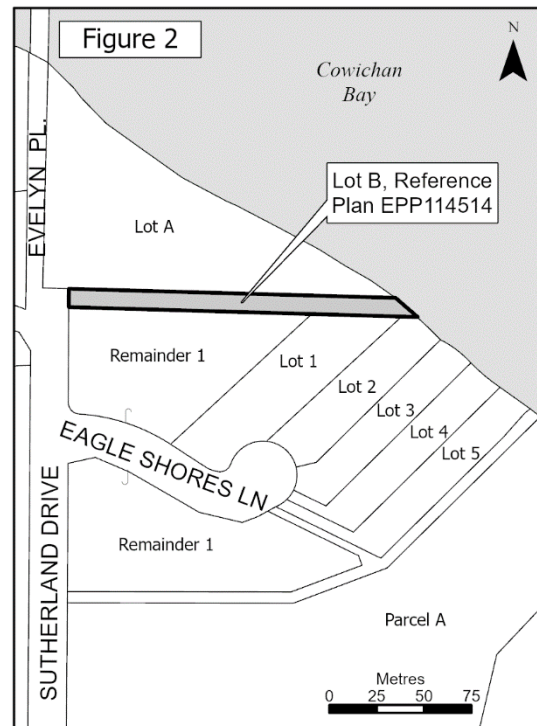
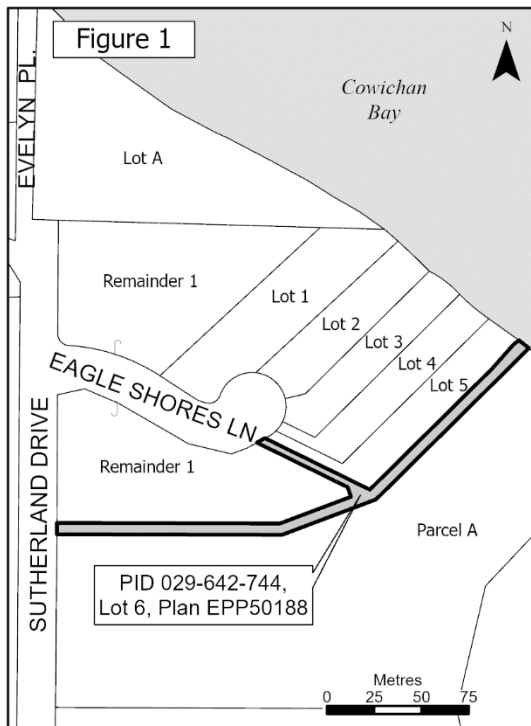
