

Report from the Communications and Engagement Division Re: Community Satisfaction Survey

It was moved and seconded on October 9, 2024 that it be recommended to the Board:

- 1. That the CVRD conduct an updated Community Satisfaction Survey in Q4 2024; and
- 2. That the 2024 budget for Function 100 be amended to
- a. Increase expenditures by \$25,000; and
- b. Increase contributions from General Government reserves by \$25,000.

Staff Report from Emergency Management Division Re: Penelakut Tribe Fire Dispatch Agreement 2024-2028

The CVRD has provided fire dispatch services including paging, operational radio and fire dispatch services to the Penelakut Island Fire Department and Medical Responder Group under a service agreement for the period of 2019-2023. The Penelakut Tribe wishes to renew the fire dispatch services agreement for the five (5) year term of January 1, 2024 to December 31, 2028. It was moved and seconded that the Cowichan Valley Regional District enter into a five-year (5) year agreement with Penelakut Tribe for the period of January 1, 2024 to December 31, 2028, for the provision of Fire Dispatch services to the Penelakut Island Fire Department and Medical Responder Group.

Discontinuation of Transit Fare Tickets and the Full Transition to Electronic Fare Products (Update)

As of October 1, 2024, riders will need to use cash or electronic payment methods like reloadable cards or smartphone apps. This transition is part of a broader effort to modernize fare collection across the Province. While CVRD vendor sites will continue to sell electronic fare products, traditional monthly passes and tickets will no longer be available. BC Transit is also working on implementing contactless payment options like debit and credit card taps on board transit.


Fares subject to change

Cash, DayPASS and Umo fare products are accepted on board. Paper tickets and passes remaining circulation will continue to be accepted. Umo is currently not applicable to handyDART.

Transit Service Agreement with Halalt First Nation

It was recommended to the Board on September 11, 2024 that the Cowichan Valley Regional District enter into a five-year Transit Service Agreement with Halalt First Nation commencing October 1, 2024, as described in the staff report to the September 11, 2024 Committee of the Whole.

Shawnigan Village Water System Service - Alternative Approval Process Results

Results of Alternative Approval Process (AAP) for the CVRD's acquisition of the Shawnigan Village Water System were received and approved at the October 2, 2024 Special Board meeting. Staff report recommendations from the Utilities Division that the 2024 Budget be amended to include a new function for the Shawnigan Village Water System Service for the 2024 budget year, effective from the date of CVRD acquisition was moved and seconded.

Cobble Hill's First FireSmart Recognized Community: Springwood Park Leads the Way

Springwood Park in Cobble Hill is celebrating FireSmart Neighbourhood Recognition! Homeowners are pursuing a plan developed in collaboration with Trevor Reid, FireSmart Coordinator for Emergency Management Cowichan (EMC), and Fire Prevention Officer, Lieutenant Arnie Sanford of the Mill Bay Fire Department to reduce the wildfire hazards in their community.

Springwood Park Mobile Home Community, like many mobile home parks face challenges such as high building densities, emergency access challenges, and hazardous vegetation. Residents collaborating with their neighbours and FireSmart have made significant progress in reducing wildfire risks and developing plans for future improvements to their neighbourhood.

For their first year of FireSmart recognition, these pro-active seniors led their fellow residents on a pathway to resilience by focusing on key projects such as installing hi-visibility address markers for emergency response, working with Park management renovating a critical water supply building, and removing highly-combustible conifers near homes. Community residents were thrilled to see all the positive changes made in just one year. On July 16, 2024 we celebrated their achievements throughout 2023 with live music and a barbeque.

At the celebratory BBQ homeowners expressed a sense of accomplishment and looked forward to participating in future efforts.

Barb Bennett, a Springwood Park resident, shared her experience:

"My husband and I are retired on a fixed income. We knew our home was vulnerable to wildfire but we've found it challenging to keep up with the maintenance. The FireSmart Team provided an assessment that really focused our efforts on the easiest and most effective improvements to our home. Our whole neighbourhood has been talking about wildfire safety this summer and I think we've made really positive changes here."

It takes a community to defend against wildfire and working together realizes more effective results. Recognition is renewed annually through ongoing mitigation projects such as hedge pruning and enhanced home construction.

EMC's regional FireSmart representatives are looking for other neighbourhoods ready to be proactive in adapting to the increasing wildfire threat. Interested homeowners can contact EMC for a community presentation and hazard assessment. Once the assessment is complete, homeowners form a FireSmart Committee to submit their plan to FireSmartBC. Neighbourhood committees plan their community activities annually through informal meetings to maintain their FireSmart status. With funds available from Firesmart BC for local plans and to celebrate successes, the path to a safer, more resilient community is clear.

In the CVRD, agriculturally zoned lands include all lands within the Agricultural Land Reserve (ALR)(External link), plus lands that have high agricultural potential, as identified in the anticipated Modernized Official Community Plan (MOCP).

Currently, there are 36 distinct agricultural zones within the CVRD's existing zoning bylaws. As part of the development of a new region-wide Comprehensive Zoning Bylaw (CZB) for the CVRD's nine electoral areas, the CVRD is updating its agricultural zoning regulations.

Formerly known as the New Normal, www.CowichanAdapts. ca is an important resource for residents to access information about climate change, a global issue that is impacting BC communities at a local level.

increased likelihood of impacts including prolonged heat waves, wildfires, droughts, and flooding.

CVRD joins other Island governments in adopting new bylaw adjudication system

The CVRD is introducing a new Bylaw Dispute Adjudication System in addition to municipal ticketing, which will allow some bylaw disputes to be dealt with at the local level, rather than the Provincial Court system.

Under the new system, Bylaw Offence Notices can be disputed out of court with an adjudicator appointed by the Provincial Attorney General's Office. The new system simplifies the dispute process and makes it more convenient for disputants, as their attendance at an adjudication hearing is not mandatory. Backyard Burning Window - Know the Rules

October 15 - November 15

The open burning window begins on October 15 and runs until November 15.

Do you know the rules and restrictions?

The open burning window applies to Electoral Areas A, B, C, D, E and G (excluding the Gulf Islands) under Smoke Control Regulation Bylaw No. 3716. Electoral Areas F, H, and I must adhere to restrictions set in place by the Ministry of Environment and Climate Change Strategy.

The Cowichan Valley is a high smoke sensitivity zone. To protect local air quality during the open burning window, residents must check the South Vancouver Island Venting Index and only burn when rated "GOOD".
