

Are you a customer of a CVRD water system? Water main flushing is ongoing through March and ends on Friday, April 25, 2025.

Backyard Burning - CVRD bylaws specify the allowable burning dates each year are March 15 to April 15 and October 15 to November 15 for Electoral Areas A, B, C, D, E and G (with the exception of the Gulf Islands)

Residents in Areas F, H, and I must adhere to restrictions set in place by the Ministry of Environment Climate Change Strategy.

Backyard burning is completely banned in the following local municipalities:

FireSmart rebates now available for Ladysmith, Duncan and CVRD Electoral Areas

Emergency Management Cowichan (EMC), on behalf of the CVRD, the Town of Ladysmith and the City of Duncan, will be launching a FireSmart Rebate program to support homeowners in performing Firesmart activities on residential properties.

The Cowichan Regional
FireSmart Resiliency Program is
designed to help homeowners
and communities reduce the risk
of wildfire damage. Wildfires are a
natural occurrence, but they can
also be devastating to homes,
businesses, and communities.
A Wildfire Home Assessment,
available free from EMC, will
help home owners identify easy

steps and actions to reduce their property's risk to wildfires. In 2023-2024, more than 200 homes were assessed in the Cowichan region. Recommendations in FireSmart home assessments can now be funded for eligible applicants under this rebate program.

"The frequency and intensity of wildfires have increased, making it more important than ever to take steps to protect our community," said Chris Geiger, Town of Ladysmith Fire Chief. "This rebate program will provide funding to families who want to take steps to protect their home from wildfire, making us more resilient in the future."

Applications for rebates up to \$4,000 will open on March 19th, 2025 at a limited amount per community. To be eligible for a rebate, homeowners in the Town of Ladysmith, the City of Duncan and the Electoral Areas of the CVRD must have a free FireSmart Home Assessment completed, and be willing to complete approved FireSmart work within 90 days of the application approval.

CVRD signs MOU with Cowichan Search & Rescue Society to explore new facility options at Bings Creek

CVRD has signed a Memorandum of Understanding (MOU) with the Cowichan Search and Rescue Society (CSAR) for a proposed new facility at the site of the Bings Creek Recycling & Waste Management Centre.

The MOU follows previous capacity assessment work for future expansion of the Bings Creek site which explored use of the site to further incorporate CVRD Parks & Trails, Utilities and Recycling & Waste Management staff. The assessment also identified opportunities for future consideration of existing tenants, including Emergency Management Cowichan and

"We are grateful to the many volunteers of Cowichan Search & Rescue Society and the service they provide to residents of the Cowichan region," said Kate Segall, Chair of the Cowichan Valley Regional District Board of Directors. "This MOU will provide them with the ability to develop a new permanent facility to house

their equipment, conduct training, and help prevent the loss of life when unfortunate circumstances occur in our communities."

In February 2024, CSAR submitted correspondence to the CVRD stating that their current facility was no longer adequate to support their operational needs. "The Bings Creek site is ideal for us due to its central location for the CSAR service area, and enhances our ability to effectively respond when we're called to action," said Jamie Tudway-Cains, CSAR Search Manager and Past President. "We've enjoyed a 15 year relationship with the CVRD at this site and appreciate the continued support to ensure CSAR can continue its role in emergency response for residents of the Cowichan region."

CSAR currently occupies two service bays at the Bings Creek site, which includes a meeting/training space. At this time, the location of a new CSAR facility within the Bings Creek site has not been identified; however, CSAR has determined their future needs will include approximately 1.8 acres, with accommodation of up to 60 parking spaces.
