acknowledge and agree that in consideration of being permitted to have my child participate in RICHARDSON SPORT INC. organized staged and/or operated by RICHARDSON SPORT INC. (hereinafter referred to as "RICHARDSON SPORT INC.").

1. I DO HEREBY RELEASE RICHARDSON SPORT INC. and its directors, officers, employees, sponsors, independent contractors and agents from all liability, and DO HEREBY WAIVE as against RICHARDSON SPORT INC. and its directors, officers, employees, sponsors, independent contractors and agents all resources, proceedings, claims, and causes of action of any kind whatsoever, in respect of any and all personal injuries or property losses which my child may suffer arising out of or connected with my preparation for, or participation in RICHARDSON SPORT INC. notwithstanding that such injuries or losses may have been caused solely or partly by the negligence or breach of duty of RICHARDSON SPORT INC. or any of their directors, officers, employees, sponsors, independent contractors or agents.

2. I HEREBY ACKNOWLEDGE AND AGREE THAT:

- CAMP may be dangerous, exposing participants to many risks and hazards, some of which are inherent in the very nature of CAMP itself, others which result from human error and negligence on the part of the persons involved in organizing, staging and/or operating the CAMP;
• as a result of the aforesaid risks and hazards, my child as a participant may suffer serious personal injury, even death, as well as property loss;
• some of the aforesaid risks and hazards are foreseeable, but others are not;
• I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that, accordingly, my



preparation for, and my child's participation in CAMP *shall be entirely at my own risk;*

- I understand that neither RICHARDSON SPORT INC. nor any of its directors, officers, employees, sponsors, independent contractors or agents assume any responsibility whatsoever for my child's safety during the course of my preparation for or participation in CAMP. I have carefully read this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT (the "Agreement"), that I fully understand same, and that I am freely and voluntarily executing same;
- I clearly understand that by signing this Agreement I will be FOREVER PREVENTED FROM SUING OR OTHERWISE CLAIMING against RICHARDSON SPORT INC. its directors, officers, employees, sponsors, independent contractors and agents for any loss or damage connected with any property loss or personal injury that my child may sustain while participating in or preparing for CAMP whether or not such loss or injury is caused solely or partly by the negligence of RICHARDSON SPORT INC. or any of its directors, officers, employees, sponsors, independent contractors and/or agents;
- I have been given the opportunity and have been encouraged to seek legal advice prior to signing this Agreement;
- I clearly understand that RICHARDSON SPORT INC. would not permit my child to participate in CAMP unless I signed this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT, that this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT applies to CAMP whether occurring in the near or distant future and that the terms of this Agreement have been explained to me by RICHARDSON SPORT INC. or one or more of their representatives;
- this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT is binding on myself, my heirs, my executors, administrators, personal representatives and assigns;
- this Agreement may be in addition to another agreement I must sign as a condition of participation in CAMP and that I am bound by the terms and conditions of both agreements; and
- I agree that my child is physically capable of participating in CAMP, and that they have no pre-existing conditions that would hinder my ability to participate in CAMP.

This Agreement must be completed in full, initialled, dated, signed and witnessed prior to participating in CAMP.
